National Science Foundation S-STEM Grant Natural Resources Program

- ► The National S-STEM we grant is a 6-year grant project titled Equitable Learning to Advance Technical Education, and was awarded to Green River in the amount of \$1,497,591
- ► The grant period is from 10/1/22 9/30/28.
- ► This project builds on lessons learned from a previous NSF S-STEM grant awarded to the Natural Resources program.
- ► The overarching goal of the grant is to reduce barriers to completion and employment for under-served students in this field.
- ► This grant strengthens and provides financial resources to the collaborative worth that the project Principal Investigator Dr. Monica Paulson Priebe from GRC Natural Resources and Dr. Denise Bill the Executive Director for Adult Education at the Muckleshoot Tribal College (MTC) to support, renewable, year-long scholarships for underserved and underrepresented populations to pursue an education and career in Natural Resources.

Funding Uses and Project Goals:

- The funding is split into three primary areas,
 - 1) Mentorship and cohort building,
 - 2) Student support scholarships,
 - ▶ 3) A Tribal Natural Resources Pathway Manager to support students at GRC and MTC through their entire education.
- ► This grant works in tandem with the CEDAR tree pathway project associated NACTEP grant awarded to MTC by the US Dept of Ed, and TRiO, which helps provide further funding and support to students.
- Students receiving a scholarship will be able to participate in state and national natural resource related conferences, be paired with an industry mentor, and have access to advising that focuses not just on classes, but also support students in goal setting and building self-efficacy.
- ► We will also build further opportunities to earn relevant certifications to compliment their degrees, for example chemical applicators licenses or Python programming skills for use with mapping and statistics.
