There continues to be confusion with College Council and our purpose. Ex-Officios are representatives of exec staff but they don't weigh in on everything or abstain from participating in making certain decisions.

ACTION ITEM-Draft a formal request to keep existing structure but improve with the following suggestions:

Meet with exec staff regularly. If we did would there be need ex officio representation on the council?

Recommend expanding College Council to include areas that aren't represented i.e. Human Resources, Branch Campuses, College Relations, IT.

Create venue options that allow others to attend i.e. call in to meeting.

Formalize a way to have consistent interactions with executive staff. For example a "joint meeting" that would include representative of council to attend their meetings. Recommend monthly meetings.

Suggestion- Outstanding Staff Committee vet through College Council.
