Effective 02-09-2017 the Green River College Campus Safety Department will only post incidents related to criminal activity. This change is in order to meet the requirements of Chapter 5 page 5-2 of the 2016 Handbook for Campus Safety and Security Reporting published by the US Department of Education, specifically "The purpose of the daily crime log is to record all **criminal incidents** and **alleged criminal incidents** that are reported to the campus police or security department." All other aspects of the Daily Crime Log remain the same.

As of 07-12-2017 the Green River College Campus Safety Department will only post incidents related to Auto Accidents which are **criminal in nature**. All other aspects of the Daily Crime Log remain the same.
