PART 1: APPLY ONLINE

DETERMINE COURSE PLACEMENT



PART 1: ENGLISH REQUIREMENT

To participate in Running Start you must be eligible for college-level English (Engl& 101). Students may qualify for Engl& 101 utilizing cumulative high school GPA.

If placement by transcript is not an option, students may place into Engl& 101 by taking the Directed Self-Placement (DSP).

PART 2: MATH AND OTHER SUBJECTS

Math placement, although not required for Running Start, is necessary for some courses. Placement into math, science, and language courses can usually be established with an unofficial high school transcript. We will address this during the orientation process.

PART 1: OBTAIN RS FORMS

Complete your **Enrollment Verification Form (EVF)** with your high school counselor.

- » For home or private school students, you must enroll in your local district to access the Running Start Program. You will need to provide them with proof of eligibility for Engl& 101.
- Complete the Running Start Enrollment Packet with your parent/guardian.

PART 2 SUBMIT DOCUMENTS

Submit the following documents to the Running Start Office at greenriver.edu/upload:

- » The Enrollment Packet
- Your signed EVF
- » *An unofficial HS transcript
- *A list of remaining HS grad requirements.
 - *Not required for home school students.

PART 1: RAP SESSION

Once documents are processed, students will receive an email to their GRC student email to sign up for a mandatory **Running Start Advising and Planning (RAP)** session through **Navigate**.

After attending, you can enroll into classes.

Note: Space is limited. Seats are reserved for students only. A parent/guardian orientation will be held in September.

PART 2: VERIFY ENROLLMENT

Running Start is a statewide partnership between community and technical colleges and high schools.

High school juniors and seniors can attend college tuition-free (see chart below). Earned credits count toward high school and college completion, saving families significant money as students begin their college career.

Students interested in the Running Start Program should weigh the benefits and considerations of participating to determine if this program is a good fit. Green River is committed to providing inclusive, equitable access to comprehensive educational programs.

BENEFITS OF PARTICIPATING

- » Running Start students do not pay tuition for college-level courses, up to 21 credits per quarter.
- » Pursue hands-on career training programs, like automotive, aviation, nursing, software development and more.
- » Larger variety of classes than offered in the high school.
- » Flexible class schedule; day, afternoon, evening, hybrid and online courses available, with multiple campus locations.
- » Smaller class sizes than major universities with an average student to instructor ratio of 32:1.
- » Earn high school and college credit simultaneously.
- » Potential to earn an associate's degree along with high school or college-awarded diploma.
- » Experience college coursework and increased personal freedom.
- » Participate in college leadership opportunities and activities, excluding intercollegiate athletics.



RUNNING START SAVES YOU

- * Approximate cost (varies by class schedule).
- ** Fee Waiver and Book Loan Program waives student-voted fees and assists with books.
- *** Actual tuition savings varies (based on high school enrollment). Sudents are eligible for a maximum of 21 credits of free tuition fall, winter, and spring quarters; up to 10 credits summer quarter. Students are responsible for tuition in excess of the approved credit maximum as determined by their high school or district, and tuition for pe-college coursework (below 100 level).

WHAT TO CONSIDER

- » Classes move at a faster pace than high school. 1 quarter (10 weeks) = 1 year of high school.
- » College requires time management. Keep both HS and GRC in mind when scheduling classes and other commitments. Often, HS and GRC breaks do not align.
- » College is an adult learning environment. Classroom topics cover contemporary and world issues, which may contain sensitive themes.
- » Students arrange their own transportation to/from GRC; campus parking is free, but limited.
- **»** While tuition is free, attending college is <u>not</u>. Students can expect to pay about \$475 per quarter for fees/books.
- » A Fee Waiver Program is available for eligible students.

 Qualifying students will have student-voted fees waived and can borrow books each quarter.

 An application is required.
- » Parent or guardian access to student records is limited.

The college must abide by strict privacy rules. The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal law protecting the privacy of student records. All RS students are provided the opportunity to complete a Release of Information Form, granting specific people access to their records.
